## UNIVERSAL ADULT / MINOR MODEL RELEASE

For good and valuable consideration, the receipt and sufficiency of whi	ich is hereby acknowledged by the Model, both parties

in this Agreement agree on the following conditions:

### 1. DESCRIPTION OF PHOTOGRAPHS

**1.1** This Agreement is applicable to all photographs, irrespectively of their format, and size that are owned by the Model (hereinafter, referred to as "the Photographs") and the Model's Property made by the Photographer and to modifications of such Photographs.

## 2. USE OF THE PHOTOGRAPHS

- **2.1** The Model hereby explicitly authorizes the use of the Photographs by the Photographer and the Photographer's authorized representatives for any purpose, excluding defamatory or pornographic uses. The allowed purposes include, but are not limited to, sale, reproduction in all media, publication, display, broadcast and exhibition for promotion, advertising, trade, art or illustration.
- **2.2** Model also allows the Photographer to use any printed versions of the photographs.
- **2.3** The Model hereby agrees that, while his/her personal information will not be made publicly available, it may be used directly in relation to the licensing of the Photographs where necessary. The Model further agrees that his personal information may be retained as long as necessary to fulfill the aforementioned purpose.

## 3. RIGHTS IN THE PHOTOGRAPHS

- **3.1** The Model agrees that the Photographs will be used without further compensation for an indefinite period time and that this Agreement is irrevocable.
- **3.2** The Model hereby waives any right to additional consideration.

- **3.3** The Model hereby acknowledges that he or she has received consideration for the rights granted in this Agreement.
- **3.4** The Model hereby acknowledges that he or she will make no further claim for any reason to the Photographer.

# 4. RELEASE OF PHOTOGRAPHER FROM LIABILITY

- **4.1** The Model releases the Photographer and his representatives from any liability related to any alteration, distortion, optical illusion, blurring, or use in composite form whether intentional or not, that may be a result from the taking of the Photographs.
- **4.2** The Model releases the Photographer of any claims for libel or invasion of privacy.

### 5. CAPACITY

- **5.1** If the Model is an adult: I, the Model, warrant and represent that I am not a minor, and do have the legal age or status in my country to sign this Agreement. For the purpose of this Agreement, a "minor" is any person under the age of 18 years.
- **5.2** If the Model is a minor: PARENTAL AUTHORISATION. I warrant and represent that I am the parent or guardian of the Model above named. I have read this authorization, release, and Agreement in full, prior to its execution, and I am perfectly familiar with its contents. This Agreement shall be binding upon me and my heirs, legal representatives, and assigns.
